

PRESIDENT'S MESSAGE

The month of August begins with the completion of the road paving project that was approved in the 2023 budget. The paving included N. Arborea, N. Lakeview, N. Toronja, S. Lantana, Ponce de Leon from Park Ave. to Granada Dr., and the turnabout at the pavilion. This paving was done at a cost of \$486,000. This represents a fraction of the roads that need paving. It should be clear to everyone that in order to pave more roads additional funding is the only way we will be able to do it. I do understand that everyone wants their road paved but it's just not possible at this time.

We are entering the third month of Hurricane Season and with the exception of the possible development of a Tropical Storm there is currently no activity in the Atlantic. We will update with any new information on our Facebook page, website, and electronic message boards. Please stay prepared and vigilant as things can change quickly.

As President I am happy to report that the Budget "carryover" for 2023 was \$991,000 compared to 2022 when the carryover was only \$66,000. This should make it absolutely clear that we worked hard to contain costs to not waste money needlessly. This doesn't happen without the Board in conjunction with our Business Manager and Department Supervisors working together with the common goal to make Indian Lake Estates better. The Board of Directors has approved several projects while not noticeable are essential that they get done. The tennis court will be resurfaced and reconfigured to accommodate both tennis and pickleball courts.

Board meetings and workshops are now being hosted via Microsoft Teams. Check our Facebook page for the link to join us virtually. This has been asked for a long time. Thanks to Rod Raner for making it happen. We used it last workshop and Board Meeting And it seemed to work fine I am confident this will be the new norm.


